BLS Regional CME Requirements:

- **BLS skills are due annually prior to December 31st.**
- Submit the BLS skills sheet to the primary Agency CME Manager. Provide a copy to any secondary agencies and keep a copy for your records.
- Failure to complete the NCEMS Regional CME requirements and submission to Agency CME Manager prior to the deadline will result in **AUTOMATIC SUSPENSION of BLS provider's ability to provide treatments approved as regional BLS adjuncts: Narcan, Albuterol, CPAP, and Blood Glucometry.**

Privileges Suspension Notification:

- The Agency CME Manager is responsible for notifying the provider that the NCEMS Regional CME requirements were not completed.

Privileges Reinstatement:

- Upon completion of the NCEMS Regional CME requirements and submission to the primary Agency CME Manager, the provider's privileges are reinstated once the Agency CME Manager updates the provider's CME status in the NCEMS website and notifies the Program Agency.

Regional CME Requirements for Newly Certified BLS Providers:

- The provider is required to complete the Regional CME skills for the year when they become certified.

Failure to comply with regional CME requirements:

- If by the end of the CME year BLS providers will not be able to provide any adjunct treatments that their agency is approved for: Albuterol, Narcan, CPAP, Blood Glucometry
- **Providers will be charged a \$25.00 fee to come back online if the suspension is the second occurrence within three years.**
