- Have the appropriate equipment available to provide hands on scenario-based CME sessions
- Agree that each session will be conducted via hands on scenario requiring providers to utilize critical thinking and they must perform the skill as they would in the field.

- Agree to maintain sign in/out sheets for each CME session at agency.
- Agree to schedule CME sessions open to all regional providers by January 1st for the first semester and by July 1st for the second semester.
